

# **TRAFFIC AND PARKING RULES AND REGULATIONS**

## **OF THE PVA EXPO PRAGUE EXHIBITION CENTRE**

**(hereinafter referred to as "Traffic and Parking Rules and Regulations")**

### **I. Basic provisions**

1. The present Traffic and Parking Rules and Regulations are valid throughout the PVA EXPO PRAGUE Exhibition Centre, Beranových 667, Prague 9 – Letňany (hereinafter referred to as "the Exhibition Centre").
2. The term "Parking Area of the Exhibition Centre" shall denote the hard-surface parking area inside the Exhibition Centre in front of Entrance Hall II (hereinafter referred to as "the Parking Area").
3. A person entering the Exhibition Centre with a vehicle (hereinafter referred to as "the User") is obliged to comply with the Act No. 361/2000 Coll., on Road Traffic and the relevant implementing regulations when driving within the Exhibition Centre, and by entering the Exhibition Centre they shall get subjected to the rules set out in the present Traffic and Parking Rules and Regulations and the traffic signs placed at the entrances into the Exhibition Centre.
4. Standing time in the Parking Area is only permitted during the operating hours of exhibitions or trade fairs or other events, if so determined by the operator.

### **II. Basic Rules**

1. The operator specifically notes that the Parking Area is not guarded. The operator does not provide any services in connection with the parking of vehicles and is not responsible for the loss or destruction of vehicles or their contents or for any other damage to property or personal injury that occurs in the Parking Area.
2. The vehicle must be properly locked after parking and the Parking Area must be vacated immediately. It is forbidden to carry out any maintenance, treatment, washing or repair work on the Parking Area.
3. The User must comply with all instructions of the Parking Service within the Parking Area.
4. Placing or handing out promotional items in the Parking Area is prohibited.
5. The maximum speed limit for all vehicles on the roads inside the Exhibition Centre is 15 km/h, while the maximum speed limit in the Parking Area is 5 km/h. Drivers are required to adjust their speed to the above-mentioned speed limits, the nature of the load, visibility, road conditions or the traffic situation at the time.
6. Vehicle traffic is almost restricted at the Exhibition Centre during the events. If it is necessary to carry out transport at this time, the driver must give way to pedestrians and limit their speed to achieve maximum pedestrian safety.
7. Motorcycle parking is only allowed in designated areas of the Parking Area as directed by the Parking Service.
8. It is forbidden to enter the exhibition halls with all motor vehicles and mechanisms without the appropriate permit.

9. Vehicle parking in the Parking Area is limited to operation hours for the term of events at the Exhibition Centre. Users are required to leave the Parking Area no later than 60 minutes after the end of the event. The Operator shall be entitled to remove or secure the parked vehicle at the User's expense and risk after this time.

### **III. Fee for the use of the Parking Area**

1. There is a charge for using the Parking Area for parking vehicles. The amount of the fee is determined according to the nature of the event and is always indicated at each entrance into the Parking Area, at the ticket office and on the parking ticket, i.e., the User is informed about the price of the parking fee before entering and using the Parking Area. Exit from the Parking Area is only possible after payment of the parking fee.
2. The User will receive a parking ticket upon payment of the fee at the ticket office for the event being organised at the Exhibition Centre or upon exiting the Parking Area after paying the parking service.
3. At the User's request, the parking ticket will be supplemented with the legal prerequisites and will also serve as a tax document for the payment of the parking fee.
4. The parking ticket authorises the User to a single use of the paid parking space during one day, regardless of the duration of the parking time. The Parking Ticket shall be invalidated by the separation of the control slip when exiting the Parking Area and cannot be used again the same day. Therefore, the parking ticket shall not be used to re-enter the Parking Area.
